In response to announcement in the Official Journal of the European Union no. **2018/S 171-389187** dated 3.09.2018 about architectural-urbanistic, two-stage, implementation-based Competition for the development of architectural and urban concept of **Centrum Literatury i Języka – Planeta Lem (Literature and Language Centre – Planet Lem)** (hereinafter referred to as the “Competition”) pursuant to requirements specified in the Competition Regulations (hereinafter referred to as the “Regulations”), I hereby file/we hereby file an application for an admission to participate in the Competition and declare that:

1. I/we have read the announcement about the Competition and the regulations along with all attachments, in particular with the template of an agreement for the performance of design works, which constitutes Attachment no. F13 to the Regulations and all clarifications and their amendments and I /we do not file any objections and accept the terms contained therein and accept all information contained therein as sufficient to prepare a competition entry.
2. I am / we are bound by the regulations.
3. As a participant in the Competition, taking part in the Competition individually, as well as each participant jointly participating in the Competition, listed in this request for admission, I submit a declaration in the form of an European Single Procurement Document (ESPD), pursuant to Attachment No. F2 to the Regulations, in order to acknowledge the compliance with all conditions for participation in the Competition and no grounds for exclusion from the Competition.

I/we declare that that I/we grant to the Organizer, i.e. the Krakow Festival Office, a free non-exclusive license, unlimited territorially and with no time limits, from the moment of approval of results of the Competition by the Organizer's Manager, until presentation and first public access to my / our competition entry / study, during public post-competition exhibition and as part of post-competition publication pursuant to detailed provisions of point 8.1.2 of the Regulations, as well as its reproduction and publication using any technique (including printing, reprographic and digital recording) and to lend and make copies of this work, and also its dissemination in the form of an exhibition catalogue - printed or digital - also on the Internet and in other media. I /we also grant a consent to make necessary modifications regarding the edition (with regard to change of format or form of presentation) of elements of the competition entry, in connection with publication of competition entries in the manner and for the purposes described above.
8. In case I/we get an award or honorary distinction, I/we grant to the Organizer, i.e. the Krakow Festival Office, an exclusive license for an indefinite period, without territorial restrictions to competition entries, including studies, upon announcing the results of the Competition, in the following fields of exploitation:
  - posting, recording, multiplying and using on any scale or in part in all materials published by the Krakow Festival Office or entity designated by the Krakow Festival Office for promotional purposes, in particular in the form of printed publications, boards, on computer disks and all types of media designed for digital recording,
  - introducing in any part to the Internet, including posting and using as part of online publications,
  - public exhibiting in particular during the post-competition exhibition, displaying, reproducing and broadcasting and rebroadcasting via wired and wireless vision by terrestrial stations, broadcasted via satellite and the Internet,
  - using in any part for the purpose of advertising, promotion, designation or identification of the Krakow Festival Office, its programs, broadcasts and publications, and preparation of foreign language versions.

In addition, I/we undertake to sign an exclusive license agreement constituting Attachment no. F14 to the regulations after announcing the results of the Competition at the request of the Organizer.
9. I/we declare that the License referred to in point. 7 may be terminated with a five-year notice period.
10. I/we declare that I/we understand that granting the license referred to in point 7, obligates the Organizer to enter each time the name of the participant / participants of the Competition and the composition of the authors team, as per the will of Competition participant in the above mentioned fields of exploitation, unless as a participant/participants of the Competition I/we stipulate that I/we do not wish to post such

11. If my/our competition entry is regarded by the jury as the best, I undertake to sign at the request of the Competition Organizer an agreement of transfer of the proprietary copyrights in accordance with the specimen attached as Attachment no. F15 to the competition regulations. I/we declare that I/we transfer to the Krakow Festival Office proprietary copyrights to this competition entry on fields of exploitation and on terms specified in the transfer agreement referred to above.
  12. I/we declare that I/we will be entitled to proprietary copyrights in the scope specified in the regulations with regard the submitted competition entry.
  13. I/we declare and guarantee that the use by the Organizer of the competition entry will not infringe any rights of third parties, including proprietary copyrights and moral rights of third parties.
  14. As a participant/participants of the Competition, I/we accept responsibility towards the Competition Organizer for any legal defects of the competition entry, and in particular for any claims of third parties against the competition entry resulting from violation of intellectual property rights.
  15. I/we declare that at each stage of the Competition I/we will take into account the guidelines of the Jury.

If I receive 1 prize in the form of an invitation for negotiations as single-source procurement procedure for development of studies referred to in the regulations, I/we undertake to enter these negotiations within deadline specified in the regulations and in place indicated by the Competition Organizer.
