#### Europe's Mayors push for green and inclusive recovery

Addressing the effects of climate change while pursuing economic growth was the ambition for the mayors of Europe's biggest cities meeting at 'EUROCITIES 2009 Stockholm'. With some 400 participants, this year's conference discussed the views and actions of cities in addressing the environment-economy connection. EUROCITIES President Jozias van Aartsen, Mayor of The Hague, shared his vision on the issue:

"Climate change is not just about the environment. It is THE social, economic and political issue for every city in Europe and worldwide. Any growth strategies of the future must be green and inclusive.

Cities have a key role to play in enabling local economies to anticipate and adapt to climate change to achieve economic recovery and sustainable growth."

The EUROCITIES conference was timely as it took place under the auspices of the Swedish Presidency of the EU, and just three weeks ahead of the United Nations Climate Summit in Copenhagen. The conference's political highlight was the joint 'Stockholm Appeal' by European and US Mayors to world leaders negotiating the climate change deal at COP15.

Special guests and keynote speakers at this year's event included the renowned Swedish Professor Hans Rosling, cofounder and director of the Gapminder Foundation; Sweden's Deputy Prime Minister, Maud Olofsson; Elizabeth Kautz, Vice President of the United States Conference of Mayors; Pedro Ballesteros Torres from DG Energy and Transport of the European Commission; and Robert Silverman, Chargé d'affaires, from the US Embassy in Stockholm.

Finally, this year's Mayors' Debate held during the conference engaged political debate on how best to make serious progress on the 2010 European Year Combating Poverty and Exclusion agenda.

  climate protection in an integrated

the UK through a successful partnership with local residents at the core.

The main points of the latest EUROCITIES Annual General Meeting in Stockholm on 27 November were as follows:

- New members: Bratislava,
   BrabantStad Metropolitan Area, Mannheim,
   Brighton & Hove were accepted as new
   full members; Pristina and Kharkov as new
   associate members.
- Executive Committee: Genoa, Leipzig and Zaragoza will continue as members of EUROCITIES Executive Committee (ExCom). After 13 years, Richard Leese, Leader of Manchester City Council, stepped down from the committee. Ghent was elected as a new member of the ExCom. The Hague and

Copenhagen will remain as the President and Vice-president cities of EUROCITIES.

- Internal Audit: At the beginning of 2010, EUROCITIES Executive Committee will determine appropriate working arrangements for a formalised internal audit committee and will invite EUROCITIES members to volunteer to join it.
- Change in statutes: Statutory changes to criteria regarding metropolitan areas and approval procedures for accounts of year ended were unanimously approved by the 77 members present/represented at the meeting. To reach the quorum of 93, the Brussels Office will send an email

request for an electronic vote from those who were not represented at the recent meeting.

- Operations: The 2008 accounts, 2009 Report of Activities, 2010 draft budget and 2010 draft work programme, were approved.
- 2011 conference: EUROCITIES' 2011 annual conference will take place in Genoa.

A report of the meeting will be made available to all members by mid-January 2010.

Under the auspices of the Spanish EU Presidency, EUROCITIES' Forums on Economic Development and Environment will hold a joint event in Madrid on 10-12 February 2009 to debate how cities are rethinking their role and structure against today's challenges of climate change and recession.

The meeting will look at strategies that cities are adopting to address climate targets and improve economic performance. Presentations will be given on the various measures which cities are taking such as investments in green jobs, eco-innovation, greening SMEs and use of

appropriate planning tools in order to maintair and improve standards of sustainable and economic development in today's economic context.

Representatives of the Spanish
Presidency of the EU, the European
Commission and the European Parliament
have been invited to comment on how the
EU can help cities move towards greater
sustainable economic development.

A dedicated session will be held for local politicians to discuss the importance of strong leadership in driving forward this agenda.

The event will also feature a series of workshops on city planning, eco-innovation and the role of SMEs. Working Groups associated with the Forums will prepare these workshops.

## Creativity can help Europe's global competitiveness, say experts

n a 'manifesto' for creativity and innovation in Europe, ambassadors for the European Year of Creativity and Innovation 2009 have requested that the European Commission and EU Member States give full attention to the role of creativity and innovation in the Union's strategy for the decade 2010-2020. The 'Manifesto for Creativity and Innovation in Europe' is one of the key outcomes of the European Year of Creativity and Innovation 2009.

The 27 ambassadors are leading European personalities from the arts and sciences, from industry and education, and include Ferran Adrià, often associated with 'molecular gastronomy', dance choreographer Anna Teresa de Keersmaeker, and the renowned American Professor, Richard Florida, who is best known for his work in developing the concept of the 'creative class', and its ramifications in urban regeneration.

Handed to European Commission President José Manuel Barroso on 12 November, the manifesto features a set of priorities - 'Seven commandments' as well as recommended lines of action. The commandments include:

- 1. Nurture creativity in a lifelong learning process where theory and practice go hand in hand
- Make schools and universities places where students and teachers engage in creative thinking and learning through practice
- 3. Transform workplaces into learning sites
- 4. Promote a strong, independent and diverse cultural sector that can sustain intercultural dialogue
- 5. Promote scientific research to understand the world, improve people's lives and stimulate innovation

6. Promote European Ye design processes, thinking and tools, understanding the needs, emotions, aspirations and abilities of users

Creativity and Innovation

7. Support business innovation that contributes to prosperity and sustainability.

The recommended 'Seven lines of action' include investing in knowledge, reinventing education, rewarding initiative, sustaining culture, promoting innovation, thinking globally and greening the economy.

The manifesto will feed into discussions on Europe's future innovation policy and hopefully achieve the ambition expressed by the ambassadors which is for Europe to become a bigger global player in science, culture and competitiveness

#### Six priorities on 'Promoting a creative generation' adopted by European Council

The EU's culture ministers, meeting in Council on 27 November, adopted conclusions on promoting a creative generation in the EU.

Noting that 'access and exposure to diverse cultural expressions [...] at an early age is important for personal development [...] and for equipping children and young people with [...] skills important for social inclusion, active citizenship and future employability,' the Council identifies six priority actions, which aim to:

- 1. Include a 'children and young people' perspective in relevant policies to promote culture
- 2. Optimise the potential of the education sector to enhance the promotion of creativity through culture and cultural expression
- 3. Encourage and support cultural institutions to better engage with children and young people
- 4. Promote talent and creativity through culture as part of social inclusion

strategies catering for children and young people

- 5. Promote better access to culture through the use of ICTs for all children and young people
- 6. Facilitate the exchange of good practices and develop an 'evidence base' of knowledge

### Evaluation methods for better EU cohesion policy

oth Pawel Samecki, EU Commissioner for Regional Policy, and MEP Danuta Hübner, Chair of the European Parliament's regional policy committee, have insisted on the need for evaluation to contribute to the improvement of cohesion policy performance.

Their remarks were given at the sixth European conference on the evaluation of EU cohesion policy held in Warsaw on 30 November-1 December 2009, where around 500 people participated including policy makers, managing authorities, evaluators and academics.

According to Commissioner Samecki, one of the roles of evaluation is to provide the basis for a political debate about the results of cohesion policy. He would like to launch talks between the Commission and EU Member States, and also among Member

States regarding the performance and problems of cohesion policy programmes.

Mr Samecki believes that annual political debates are needed in the Council and in the European Parliament on the effectiveness of cohesion policy. Such discussions would allow Member States to identify appropriate solutions, promote mutual policy learning and increase the visibility of cohesion policy.

Reflections from the conference will feed into ongoing debate on the future of cohesion policy by helping to improve understanding of what works, what doesn't and why. In addition, the European Commission Directorate General for Regional Policy (DG REGIO) will set up a group of evaluation experts to review and develop the Commission's evaluation guidance and will hold seminars to share examples of good evaluation practice used across the EU

#### Cluster theory and practice

Participants in the INTERREG IVC-funded CLUSNET project visited Leipzig on 25-27 November to examine the city's healthcare and bio-tech cluster.

Leipzig is in the Free State of Saxony region, which missed out on funding from the national BioRegio programme, yet started its own biotech initiative in 2000. Between 2000 and 2005 Saxony used EU Structural Funds to invest over €200 million in developing and nurturing the biotech industry in the region, split evenly between the two cities of Dresden and Leipzig.

Funds paid for business incubators, as well as 12 biotechnology junior research groups at Dresden and Leipzig Universities. Funds also supported R&D projects. Saxony has four venture capital funds that invest in life science companies, and Leipzig pledged around €13 Million for the commercial part of BIO CITY. Numerous public and private organisations are involved in healthcare and bio-technology in and around Leipzig, which are contributing to this initiative.

In Leipzig and in other seminars, the project partners have identified four prerequisites for cities to successfully support clusters:

- Management: Given the number of organisations often involved in clusters, there is a need for a lead organisation to coordinate stakeholders and drive cluster development.
- Governance: Cluster initiatives are often simultaneously active at both the regional and city levels. Clarity is needed over which competences are held where. There is also often potential to improve visibility and critical mass through cooperation between cities or clusters.
- Strategy: Cluster strategies with key objectives and milestones are important as they allow stakeholders to jointly commit to coordinated action. Such a strategy is most effective when developed in the context of a wider city strategy.
- Funding: Many clusters are supported by time-limited public funds such as EU Structural Funds. It is important that the sustainability of cluster initiatives is secured by drawing on a variety of different income streams beyond grants.

CLUSNET will continue until late 2011. The next meeting will be in Budapest on 3-5 March.

#### The Lisbon Treaty: implications for Services of General Interest

EUROCITIES'Working Group on Services of General Interest (SGI) met in Brussels on 19 November to discuss 2010 work priorities and review new opportunities opening up as a result of the Lisbon Treaty, which entered into force on 1 December 2009.

In terms of SGI, the Treaty:

• Defines key values for SGI and ecognises the essential role of regional

and local authorities in defining and organising SGI (Protocol on SGI)

 Provides a legal basis for future European legislation on SGI (Article 14 Treaty on the functioning of the EU)

The WG members have agreed the need for cities to advocate for appropriate European legislation taking into account the principle of subsidiarity and the freedom for them to choose the is to safeguard the wide range of high quality public services provided by cities and to guarantee security of supply.

The WG will also provide input into the European debate on the draft directive on the application on patients' rights in cross-border healthcare, on the issue of social services, and on the question of state aid.

## All new buildings to be 'near-zero-energy' by 2020

Any new buildings in Europe constructed after 2020 will have to rely on renewable energy sources and consume 'near zero' amounts of energy.

This was the main outcome of a meeting on 17 November where EU legal officials agreed on the long-awaited recast of the 'Energy Performance of Buildings Directive' (EPBD). The review has been on the EU's agenda since 2008, and was pushed forward by

the current Swedish Presidency of the EU.

As buildings account for around 30% of the EU energy consumption, increasing energy efficiency in this sector could contribute significantly to the reduction of greenhouse gas emissions. This month's recast aims to increase public funds and improve the directive's energy performance certificates. In the future newly constructed

and renovated buildings will have to live up to stricter energy efficiency rules.

Moreover, every building that is sold or rented will need a certificate, pointing out the annual energy consumption, the share of renewable energies, etc.

The agreement was officially endorsed by the EU energy ministers on 7 December, reinforcing the EU's leadership position during the climate change negotiations in Copenhagen.

Cities can contribute significantly to the successful implementation of the building directive. EUROCITIES submitted a contribution to this recast early this year and will continue to follow up on any new political developments at EU level

#### 1,000th city joins the Covenant of Mayors!

On 4 December, the German city of Rostock became the 1000th signatory of the Covenant of Mayors, marking a milestone in the initiative's unprecedented growth.

Since its launch at the European Parliament in February 2009, where the first 372 signatories gathered, the Covenant has enjoyed considerable attention as the number of local authorities participating has almost trebled. Speaking of its success, EU Energy Commissioner Andris Piebalgs said "The number of communities now involved is a clear indication of the strong belief in tackling climate in a coherent way at local local."

In the meantime, the first 44 Sustainable Energy Action Plans (SEAPs) have been submitted, marking the stage at which the covenant will start to deliver results. These documents outline the workplan of local authorities for delivering on commitments underlined in the covenant. Typical areas of action focus on improvements in buildings, transport, district heating and local electricity production. To date, 77 members of EUROCITIES have signed up to the Covenant of Mayors.

#### Working Group updates

At its latest meeting in Frankfurt, EUROCITIES Working Group (WG) on Climate Change, Air Quality and Energy Efficiency discussed the air quality situation in cities with regard to the emissions ceiling directive, and agreed to review the directive's impact at city level.

Parallel to the joint meeting of EUROCITIES Forums on Environment and Economic Development, the WG will meet again in Madrid on 9-10 February 2010 to discuss the Sustainable Energy Action Plans to be developed within the Covenant of Mayors. The group will also look at the future EU Strategy on adaptation to climate change and will evaluate the outcomes of COP15.

## First 14 cities sign up to EUROCITIES' Green Digital Charter!



he mayors and leaders of 14 EUROCITIES member cities have signed the EUROCITIES Green Digital Charter which will commit them to reducing emissions through Information and Communications Technologies (ICT). An official signing ceremony was held on 27 November as part of EUROCITIES 2009 Stockholm, where around 400 delegates including mayors, politicians and stakeholders discussed local government action for a green recovery.

By signing the charter, the mayors of these first 14 cities (pictured here)- Manchester, Birmingham, Bristol, Genoa, Ghent, The Hague, Lisbon, Murcia, Nantes Metropole, Reykjavik, Tallinn, Stockholm, Vienna and Zaragoza - have agreed to:

- Deploy five large-scale ICT pilot projects before 2015;
- Decrease ICT's direct carbon footprint by 30% by 2020; and
- Create a partnership of cities on ICT & Energy Efficiency to work until 2011.

Sir Richard Leese, Leader of Manchester City Council, which is the lead city behind the intiative said: "Real opportunities exist today for harnessing digital technologies to address climate change, especially to increase energy efficiency. Cities have a crucial role to play in achieving Europe-wide climate change targets in partnership with EU institutions and Member States."

Today, conurbations across Europe are responsible for a main share of emissions, but they are also well-placed to deliver solutions. In terms of specific measures aimed at reducing emissions through IT, city councils that get behind the Charter will identify opportunities to use new technologies at a critical scale, provide for regulatory incentives, set up new types of public-private partnerships with business, industry and the voluntary sector, and share expertise and practice with fellow cities

The Green Digital Charter aims to be a catalyst for cities to work together to find creative and imaginative ways to become 'smarter cities'.

#### **Building smarter cities**

Over the past few months, EUROCITIES has been following political developments at the EU level which concern future ambitions for creating smarter cities. In line with this, our joint workshop with the European Commission on 16-17 November looked at how open innovation can support the uptake of future Internetenabled services in smart cities.

The event was closely linked to an upcoming funding call within the Commission's Information and Communication Technologies Policy Support Programme (ICT PSP). Expected to be launched in late January 2010, the call will fund up to five pilots with the aim of accelerating the uptake of innovative Internet-based technologies and services in cities.

One of the meeting's aims was to determine what is understood by the term, 'Smart City'. The consensus is that such a city is one that makes a conscious

effort to innovatively employ ICT to support a more inclusive, diverse and sustainable urban environment. The workshop also looked at:

- User-driven open innovation ecosystems, such as 'Living Labs', that aim to bridge the gap between the development of Internet-based technologies and their rapid uptake in new services.
- A cross-border network of 'smart' cities that supports the sharing of experiences and best practice in implementing open platforms for new Internet-based services in a set of key areas for cities.
- Innovative Internet-based services based on an appropriate combination of technologies such as mobile and location based technologies, broadband and high speed networks.

# Comparing digital services across 15 European cities

City governments find themselves in a transition from traditional models of local public organisation to more efficient and more effective models. Behind such transformative processes is the idea of putting citizens at the centre, and delivering user-centred and user-driven public services.

A report just published by the EUROCITIES Working Group eGovernment Benchlearning, assesses the maturity of digital public services across 15 WG member cities in 10 different countries. Respondents provided more than 1,200 inputs related to 81 different on-line services. These services were grouped according to 9 main categories shaping a 'Global Services Catalogue'. Online services have been measured based on their standard coverage across all cities and their diversity.

Besides a list of highlighted best practices, the report presents city maps to showcase areas where individual cities excel as well as areas where improvements could be carried out.

The survey was led by the city of Barcelona.

## Commission moves toward Transport White Paper for next decade

The European Commission has brought the revision of the 2001 'White Paper on Transport' one step further through a high-level conference on the future of the European transport system. Held on 20 November in Brussels, the event aimed to identify policy measures that stakeholders would like to see covered in the next European Commission's White Paper on Transport.

This new paper will define a vision for the future of transport and specific steps to be taken in the next decade and is due to be adopted in the second half of 2010, its focus will be the main transport challenges that Europe is facing today and in the years ahead.

During the event, European Commission Vice-President Antonio Tajani expressed his wish to see the creation of 'green corridors', a new dedicated fund for transport in the broad sense of the word, or the formation of a core network of TEN-T projects.

The panel discussions held during the conference focused on three main topics:

- Integrating transport modes, notably through infrastructure policy and the revision of the Trans-European Transport Network (TEN-T) policy;
- Promoting innovative technologies for clean vehicles and traffic management; and
- Responding to the future needs of both transport users and workers  $\blacksquare$

## What MEPs think of the Urban Mobility Action Plan

On 9 November, Members of the European Parliament (MEPs) held an exchange of views on the European Commission's Urban Mobility Action Plan launched in September this year. As background to the initiative, the European Parliament during the last legislature, with Gilles Savary (PSE/FR) as rapporteur, decided to take the lead with an own-initiative report in the absence of European Commission proposals.

During the exchange of views, the following points were raised:

 Actions: The European Commission representative attending explained that the Savary report is well reflected in the action plan, which is composed of 6 thematic areas and 20 separate actions. Some actions, such as an Internet site to aid public authorities for the purchase of clean and energy efficient vehicles, have already been launched.

- Modal Shift: Sir Albert Bore, rapporteur for the Committee of the Regions, also provided an overview of his assembly's views on the subject, and argued that the action plan was a positive step, though he felt there could have been a greater focus on modal shift.
- Subsidiarity: The respect of the principle of subsidiarity was felt to be particularly important, though MEPs emphasised that this should not be used as an excuse to remain inactive at EU level. They also discussed the provision and exchange of information, the use of incentives, passengers with reduced mobility, Intelligent Transport Systems and soft modes of transport.

#### New road rules come into force



New regulations modernising the rules governing road transport come into force today and are expected to generate administrative savings of €190 million a year. The Commission's new road package simplifies the legal framework for the 900,000 European road transport undertakings engaged in the transport of goods or passengers.

The regulations streamline rules in the road haulage and passenger transport sector governing entrance into the profession and access to the market. The new rules will apply in one year from date of publication/entry into force. The provisions on cabotage and 12 days derogation for the rest period for tour coach drivers will apply within six months.

## Better education for migrant children

he Council for Education, Youth and Culture called on Member States to close the achievement gap that exists between children with a migrant background and their peers in many education systems in Europe.

Proposals outlined in the Council conclusions from the meeting held on the 26-27 November include measures for:

- more accessible education systems;
- better support for schools facing particular challenges;
- better access to early childhood education; and
- greater effort to strengthen teachers' intercultural and linguistic skills.

The conclusions are the result of a European Commission consultation around the Green Paper on migration, mobility and education to which EUROCITIES Working Group Education contributed. Many of the points made by the Working Group such as the need to work closer with parents and migrant communities and the importance of support for mutual learning are mentioned by the Council.

The Council and Commission plan to strengthen a structured exchange on adapting education systems to increasingly diverse societies in the new framework for education and training (ET 2020) and within the Open Method of Coordination (OMC) on education

#### Roma exclusion requires greater attention, say EUROCITIES members

City administrations should focus on tackling Roma exclusion more effectively. This was the conclusion drawn by participants of the EUROCITIES Working Group (WG) on Social Inclusion at their meeting in Ghent on 4-5 November.

Roma people are one of the most excluded ethnic minorities in Europe. They face numerous problems in accessing basic services, such as water, sanitation and food as well as employment, education and housing. In addition, many Roma groups in Western Europe are new migrants from Eastern European urban and rural

A new report published by the Fundamental Rights Agency (FRA) further shows that Roma and travellers continue to be strongly disadvantaged in public and private housing in the EU. The report points out that most Member States have now recognised the need to adopt Roma specific initiatives in the field of housing.

So far, however, this has not resulted in the overall improvement of the housing situation of Roma. Future activities of all levels of government and equality bodies should focus in particular on combating discrimination and gathering better evidence for policies.

In light this, members of the WG Social Inclusion have agreed to scale up work in this area by improving the exchange of experiences on how to deal with the challenges faced by Roma and on the types of interventions which have proven successful. The group will also work on raising awareness of the situation among EU and national policymakers.

## EUROCITIES asks Commission to put 'people and places' at the heart of EU policy

In a letter addressed to re-appointed Commission President José Manuel Barroso, EUROCITIES President Jozias van Aartsen, Mayor of The Hague, has asked the new Commission to shift EU policy-making towards integrated EU policies that focus both on 'people and places'.

Mr van Aartsen stressed that "the global challenges of economic recession

and climate change will be won or lost in our cities" and for this reason, "cities must be real partners in EU policy-making and implementation."

Pointing to the framework of the Lisbon Treaty and its new objective of territorial cohesion, Mr van Aartsen highlighted this as a perfect opportunity for the EU to work differently, partnering with local authorities and stakeholders to deliver solutions that are appropriate to the challenges and potential of each area.

EUROCITIES will continue to follow the hearings of the Commissioners-designate in the European Parliament, focusing particularly on how they plan to work with cities in the next five years

Name: Johannes Hahn

Portfolio: Currently the Austrian minister for science and research. He studied philosophy and law. He is Head of

the Vienna branch of the conservative Austrian People's Party (OeVP) party.

European experience: Hahn has emphasised in the Austrian parliamentary hearing that he has been pro-European since his youth. His idea of Europe relates to 'bringing Europe closer to the citizens'. In the hearing, he talked

about subsidiarity and representing Austrian interests in Brussels.

Strengths: Hahn has been praised as a 'man of the future' in Austrian domestic politics, with clear ideas for a re-structuring of research investment priorities. He said he would be in favour of more money in the 8th Research Framework Programme and a re-focus on issues like climate change and education.

European Commission José Manuel Barroso announced the portfolios responsibilities of the new Commissioners-designate in late November. They will each present themselves at individual hearings before Parliamentary committees on 11-19 January 2010. The vote of consent on the new Commission as a whole is foreseen for 26 January 2010. With the Parliament's approval, the Commission will be appointed by the European Council.

## Cities advise Commission on shaping research funding for sustainable urban development

Representatives of the URBAN MATRIX project have presented the European Commission recommendations on how to shape future EU research in a way that ensures that the challenges of sustainable urban development are appropriately addressed.

Eduardo Carqueijeiro, Directorate-General Research, received the recommendations on behalf of the Commission at the URBAN MATRIX final event held on 25 November in Stockholm.

The recommendations, 'Shaping future EU research funding for Sustainable Urban Development' point to areas that the Commission should consider addressing when designing future EU research funding in a way that ensures that the challenges of sustainable urban development (SUD) are appropriately addressed. They also include suggestions on how to improve information exchanges in SUD as well as information aimed at encouraging cities to become more active in EU-funded research projects.

The recommendations are based on lessons learnt from the URBAN MATRIX four-year project which has just concluded. A collection of case studies have also been produced as part of the project. These provide practical information on a range of

local initiatives, covering topics such as urban planning, citizens' participation and public-private cooperation. The case studies are available to download from the 'good practice' page of the EUROCITIES website.

The URBAN MATRIX final event gathered over 40 participants from MATRIX partner cities as well as other EUROCITIES members. During the workshop, representatives of Helsinki and San Sebastian spoke of research and practical cooperation that had been carried out successfully in their cities.

The workshop also featured a presentation by Corinne Hermant from the European Commmission Directorate-General Regional Policy on EU indicators relating to quality of life and sustainability in European cities.

Representing the Swedish EU Presidency of the EU, Ola Göransson and Olov Schultz, hosted a discussion on the latest developments of the Reference Framework for Sustainable Cites.

This event was the last in the series of the URBAN MATRIX thematic workshops. All presentations are available in the project website. A report summarising the main elements of this latest debate and conclusions will be published soon
